There are many questions:

- What will happen to me?
- What punishment can I expect?
- Will my school/trainer find out?
- Will I have a criminal record?
- How does a court hearing work?
- Are there listeners at the trial?
- What happens if I feel I am innocent?
- What should happen next?

The offer of youth assistance in criminal proceedings is free of charge and is carried out by socio-educational specialists from the Office for Youth and Family Affairs.

We are contact persons ...

- for young people (between 14 and 18 years of age) and their parents
- for adolescents (between 18 and 21 years of age) for whom criminal proceedings are pending.

We inform ...

- about the course of the proceedings
- about a possible discontinuation of proceedings
- about the course of the court hearing
- about the consequences of the criminal proceedings

We advise ...

- about the possibilities and services offered by youth welfare services and other social services
- for problems and conflicts in the family, at school, in training, at work, among friends, etc.

We draw up

a youth welfare report in which we report on the development, living situation, social environment and future plans of the young person.

and accompany

him/her to his/her court hearing if desired.

We work out

proposals and measures to help the court and the public prosecutor make decisions.

We mediate and control

work requirements and other court measures and instructions.

Possible consequences of a criminal offence

- Employment services
- Counselling sessions (addiction, job, ...)
- Supervision instruction
- Social training course
- Reading instruction
- Offender-victim mediation
- Money order
- Anti-aggression training
- Youth detention (max. 4 weeks)
- Suspension of driving licence or driving ban
- Other orders and conditions (e.g.
- therapy)
- Life-style instructions
- Juvenile sentence with probation (without probation)
